### 6. REPORTS OF OFFICERS, BOARDS, COMMITTEES, & DEPARTMENTS

- A) E.D.A. Report Evans no report
- B) P & Z Report Director Block no report
- C) Liquor Store Report Manager Becky Vikla stated that June 2023 sales were \$108,893. June sales in 2022 were \$103,041. Sales were up \$5,851 from 2022. May gambling proceeds were \$7,685. June recap: Bean Bag tournament, Live Music by GTX Duo, Grad Parties. July Events: 4<sup>th</sup> of July, Live Music by Todd Jindra.

- D) Police Report Evans reported on the police activities for the month of June.
- E) Public Works Report Public Works Superintendent Steinborn reported the following:
  - City-Wide Clean-up day on June 17<sup>th</sup> had a total of 21 tons of garbage that was hauled away with a total price of \$4,226 including all labor. It was recommended that staff continue to run this clean-up day program on a yearly basis. Steinborn will work with LJP to set a date for next year.
  - Chip sealing is set to beginning next week and door knockers will be placed to let effected residents know.
  - Mill and overlay for Cordova is scheduled for the first part of August.
- F) Pool Report Pool Manager Dorothy Dinwiddie reported on the pool activities for the month of June: Lessons/passes \$22,530. Daily \$5,720. Concessions \$1,857. Month deposits \$30,107. Repairs are complete and new hot water heater is working well. There is still a shortage of lifeguards and scheduling on the weekends can be difficult. Dinwiddie indicate that the outfit that applied our new epoxy flooring is no longer in business, but the product is nationwide, and that company will stand behind the lifetime warranty.
- G) County Fair Board update Nancy Stauff said the following attractions will be at the County Fair this year: Axe throwing in a portable trailer and can have two people throwing at time, new bleachers are being set up in the demo derby area. Take-n-bake contest on Sunday.

### 7. OLD BUSINESS

- A) Evans summarized Attorney Moran's memorandum to the council in regards to labor negotiations with Mitch Overn as the next Police Chief. Evans indicated the following as the framework for a formal employee agreement to follow: Base rate of pay would be \$105,000 per year based off a 2080 hour work year or 40 hours per week, 80 hours per pay period. There would be a 5% COLA increase in January. He would be credited with 21+ year of service for vacation time to be accrued at the regular city rate of 7.70 hours per pay period equaling 25 days per year. He would start out with a bank of 12 days' vacation. This follows current City policy. He would receive sick time to be accrued at the rate of 1 day per month or 12 days per year. He would start out with a bank of 6 days' sick. This follows current City policy. He would be entitled to comp time at an hour-for-hour basis for any hours worked over 40 per week with a maximum accrual of 90 hours. There would be no initially banked comp time. He would receive health insurance per city policy. \$1050 uniform allowance, the current amount offered to all full-time officers per current City policy. Start date would be September 1, 2023. Motion by Hintz, seconded by Scott to approve Mitch Overn's conditional offer of employment. All in favor, motion carried.
- B) Mayor Harmeyer stated that no one turned in a city logo artwork submission. Evans advised that three (3) concept logo designs were submitted from Little Sugar Designs at the request of Evans. Council and Staff will continue to work with the designer to refine the best concepts and ideas. This topic will be tabled for now.

C) 2nd Reading & Approval of Ordinance No. 2023-2 An Ordinance Approving a Rezoning of Real Estate and Amending Document 306280, The City of Le Center Zoning Map. Motion by Scott, seconded by Hintz to approve. All in favor, motion carried.

This letter is to report the results of your recent lead/copper monitoring that is required by the Safe Drinking Water Act. The results revealed the following 90th percentile levels:

90th percentile lead level = <1  $\mu$ g/l (rounded as < 0.001 mg/l). The action level for lead is 15.0  $\mu$ g/l.

90th percentile copper level = 342  $\mu$ g/l (rounded as 0.342 mg/l). The action level for copper is 1300  $\mu$ g/l.

Based on these results, your public water system has not exceeded the action level for lead and has not exceeded the action level for copper.

By federal rule, 40 CFR 141.85, you are required to provide the lead/copper results to persons served at the sites that were tested. In addition, you must provide them with an explanation of the health effects of lead/copper, list steps consumers can take to reduce exposure to lead/copper in drinking water, and water utility contact information. The notification must also provide the maximum contaminant level goals, the action levels for lead/copper, and the definitions for these two terms.

Notification must be made within 30 days by U.S. Mail, hand/direct delivery, or posting. Please refer to the enclosed Lead/Copper Consumer Notification Certification form for delivery method requirements. If the residence is a rental property, both the occupant(s) of the residence and rental property owner must be notified. To assist you in meeting the notification requirements, we have enclosed the results notification letters which must be delivered to the homeowners along with a copy of the fact sheet on lead/copper in drinking water.

The lead/copper sampling site addresses are private data. This information was classified as "nonpublic" by the Minnesota Department of Administration in October 2004, upon the request of Minnesota Department of Health (MDH) and Minnesota community water supply systems. When notifying the persons served at the sites that were tested, provide them with the results for that address only.

Within 10 days after notifying the residents of their results, you must complete the enclosed Lead/Copper Consumer Notification Certification form and return it to us. If you chose not to use the results notification letters MDH sent to you and created your own results notification letters, you must submit a copy of one of the letters along with this certification form. The letter you create must contain the same language as the enclosed results notification letters as this is EPA required language. A return envelope is enclosed for your convenience.

Please note that all enclosures are sent to the addressee of this letter. Persons receiving a copy (cc) of the letter do not receive any enclosures. It is the responsibility of the addressee to follow through with the requirements.

A sampling kit will be sent to you prior to your next scheduled sampling date. The enclosed report should be placed in your records and a copy maintained on or near the water supply premises and available for public inspection for not less than ten (10) years.

### EMPLOYMENT AGREEMENT

This **AGREEMENT** ("Agreement") made as of the 9<sup>th</sup> day of August 2023, by and between the City of Le Center ("Employer") and Ryan Mitchell Overn ("Employee").

In consideration of the mutual covenants and promises contained in this Agreement and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Employer and Employee agree as follows:

- 1. POSITION. Employer appoints and agrees to employ Employee as its Chief of Police. Employee agrees to serve as the Chief of Police in accordance with the position description attached hereto as Appendix A, and incorporated by reference into this Agreement, as such description now exists or may be amended from time to time, and in accordance with State Statutes, policies, City Council action, and to perform such other legally permissible and proper duties and functions as are contained herein or as the City Council shall from time to time assign to Employee. Employee agrees to not become employed by any other employer, self-employment excluded, until his employment with Employer terminates in accordance with this Agreement.
- 2. TERM OF EMPLOYMENT. This Agreement shall remain in full force and effect from September 1, 2023, until terminated in accordance with this Agreement. Any existing employment agreements shall be determined void at the executing of this Employment Agreement.
- 3. **PENSION PLAN.** Employer shall contribute to Minnesota Public Employees Retirement Association (PERA) as required by State law for Employee or an alternate pension plan, if selected by Employee and authorized by State law.
- 4. SALARY. Employer shall pay Employee a gross salary of \$105,000 per year starting September 1, 2023, payable consistent with the normal payroll practices and subject to any authorized

withholdings. This salary is based off a 2080 work year or 40 hours per week, 80 hours per pay period. This amount shall be subject to a 5% COLA increase January 1, 2024.

- **5. COMPENSATORY TIME.** Employee shall be entitled to compensatory time off in accordance with the City's personnel policies, as they may be amended from time to time.
- 6. VACATION LEAVE. Employee shall be credited with 21+ years of service. Vacation shall be accrued in accordance with the City's personnel policies, as they may be amended from time to time. Currently, that accrual rate is 7.70 hours per pay period equating to 25 days per year. Employee shall commence employment with 12 days of vacation in his vacation bank.
- 7. SICK LEAVE. Employee shall accrue sick leave at a rate of 1 day per month or 12 days per year and sick leave shall be accrued according to the City's personnel policies thereafter, as they may be amended from time to time. Employee shall be credited with 6 days of sick leave in his sick leave bank upon commencement of employment.
- **8. HOLIDAYS.** Employee shall be compensated for holidays as provided to and under the same conditions as Employer's employees, pursuant to the City's personnel polices as they may be amended from time to time.
- 9. GENERAL INSURANCE. Employer shall provide Employee the same group hospital, medical, life and disability insurance benefits as provided to and under the same conditions as Employer's employees, as they may be amended from time to time. The Employer agrees to comply with all the appropriate Minnesota Statutes in regard to defending its Employees against alleged act(s) of omission occurring in the performance of the Employee's duties.
- **10. UNIFORM ALLOWANCE.** A \$1,050 annual uniform allowance shall be provided to the Employee by the Employer.

- 11. **CELL PHONE.** Employee will be provided a cell phone, paid by the Employer for use for city business or at the Employee's choice, the Employee will be paid a monthly cell phone allowance of \$50.
- 12. TAKE-HOME POLICE VEHICLE. Employee will be provided with a take-home police vehicle when available, to be used solely for official law enforcement purposes and commuting between the Employee's residence and assigned duty locations as apparent. Employee's primary residence must be located within a three (3) mile radius of the City corporate limits, to be eligible for a take-home police vehicle.
- job-related expenses, training, and professional development, which are incurred by Employee and are submitted by Employee in accordance with Employer's policies for reimbursement, as they may be amended from time to time.
- evaluate the performance of Employee at least once annually. The review and evaluation shall be done in accordance with specific criteria developed jointly by the Employer and Employee and as may be there after modified by the Employer in consultation with the Employee. The Employer and Employee shall jointly define in writing the goals and performance objectives for the proper operation of the City and the attainment of the Employer's policy objectives, and shall further establish a relative priority among those various goals and objectives. The goals and objectives should generally be attainable within the time limitations as specified and the annual operating and capital budgets and appropriations provided. Failure by either party to complete the matters described in this paragraph hereof shall not constitute a breach of this Agreement for which arbitration may be demanded or recovery may be had.

- 15. **DEATH OR DISABILITY BENEFITS.** If Employee's employment is terminated due to Employee's death or disability, regardless of the date of termination, Employee or Employee's estate or heirs, as appropriate, shall be paid (i) Employee's earned salary and accrued paid leave not paid; (ii) any unpaid expense reimbursements; and (iii) any benefits payable under any life insurance policy maintained by Employer for the benefit of Employee, subject to the terms and conditions of such policy.
- 16. TERMINATION OF EMPLOYMENT. Nothing in this Agreement shall prevent, limit or otherwise interfere with the right of Employer to terminate the services of Employee at any time, for any reason, without cause, subject only to the provisions of this Agreement and the City Ordinance. Furthermore, nothing in this Agreement shall prevent, limit or otherwise interfere with the right of Employee to resign at any time from Employee's position with Employer, subject only to the provisions of this Agreement.
- 17. VOLUNTARY AND KNOWING ACTION. The parties, by executing this Agreement, state that they have carefully read this Agreement and understand fully the contents thereof; that in executing this Agreement they voluntarily accept all terms described in this Agreement without duress, coercion, undue influence, or otherwise, and that they intend to be legally bound thereby.
- 18. AUTHORIZED SIGNATORIES. The parties each represent and warrant to the other that (1) the persons signing this Agreement are authorized signatories for the parties represented, and (2) no further approvals, actions or ratifications are needed for the full enforceability of this Agreement; each party indemnifies and holds the other harmless against any breach of the foregoing representation and warranty.

- 19. GOVERNING LAW. This Agreement and all questions arising in connection with it shall be governed by the laws of the State of Minnesota. The rule of construction of interpreting a contract against its drafter will not apply to this Agreement.
- **20. BINDING EFFECT.** This Agreement shall be binding upon and inure to the benefit of Employer, its successors and assigns, and Employee, Employee's heirs and legal representatives.
- **21. ASSIGNMENT.** The rights of Employee hereunder are personal and may not be assigned or transferred unless consented thereto in writing by Employer.
- 22. ENTIRE AGREEMENT; AMENDMENT. This Agreement constitutes the entire agreement between the parties and supersedes all prior oral and written agreements between the parties and between Employee and any other former employer relating to the same subject matter. The parties have made no agreements, representations, or warranties relating to the subject matter of this Agreement which are not set forth herein. This Agreement may be amended only if it is in writing and signed by each of the parties.
- 23. SEVERABILITY. The invalidity of any portion of this Agreement will not and shall not be deemed to affect the validity of any other provision. In the event that any provision of this Agreement is held to be invalid, the parties agree that the remaining provisions shall be deemed to be in full force and effect as if they had been executed by both parties subsequent to the expungement of the invalid provisions.
- 24. WAIVER. The failure of either party to complain of any default by the other party or to enforce any of such party's rights, no matter how long such failure may continue, will not constitute a waiver of the party's rights under this Agreement. No waiver of any provision of this Agreement shall constitute waiver of any other provision or a waiver of the same provision at any later time.

**25. HEADINGS.** Headings are provided solely for the convenience of the parties and shall not affect the interpretation of this Agreement.

**26. NOTICE.** All notices required under this Agreement shall be in writing and shall be deemed to have been duly given if sent via certified mail, first class mail-postage prepaid, hand delivery or overnight courier, and properly addressed to the party at the party's last known address or any other address that any party may designate by written notice to the other. Mailed notices shall be deemed to have been given at the time posted plus three business days.

#### **INTERIM ORDINANCE NO. 2023-3**

## AN INTERIM ORDINANCE PROHIBITING THE SALE, TESTING, MANUFACTURING, CULTIVATING, GROWING, TRANSPORTING, DELIVERY, AND DISTRIBUTION OF CANNABIS PRODUCTS IN THE CITY OF LE CENTER

The City Council of the City of Le Center does ordain:

### SECTION1. BACKGROUND.

- A. By enacting 2022 Session Law Chapter 98, Article 13, the Minnesota Legislature amended Minn. Stat. §151.72 and permitted the sale of edible and nonedible cannabinoid products that contain no more than 0.3% of Tetrahydrocannabinol, commonly known as THC ("THC Products").
- B. The Minnesota Legislature recently passed, and Minnesota Governor Tim Walz recently signed into law, Minnesota Statutes Chapter 342 which legalized THC products.
- C. Minnesota Statutes Chapter 342 establishes a regulatory framework for adult-use cannabis, as well as the lower potency hemp edibles; moves the medical cannabis program under a newly created state agency called the Office of Cannabis Management; establishes taxes on regulated products; creates grants to assist individuals entering into the legal cannabis market; amends criminal penalties; provides for expungement and resentencing of certain convictions; provides for temporary regulation of hemp-derived edible cannabinoid products; reschedules marijuana; and appropriates money.
- D. Various provisions of Minnesota Statutes Chapter 342 becomes effective July 1, 2023, and the Legislation calls for the State to establish a model ordinance for cities, which the City of Le Center would benefit from reviewing and analyzing before making any decisions related to cannabis businesses and products regulated under Minnesota Chapter 342 in the City.
- E. Chapter 342 specifies what distance restrictions cities can put in place under their zoning power. The City would benefit from having time to study and analyze acceptable time, place and manner restrictions that would be feasible for the City of Le Center as allowed under Chapter 342.
- F. Additionally, Le Center City Council passed a Moratorium which made it illegal for anyone under the age of eighteen (18) to possess in a public place THC-infused gummy candy, drinks and other edibles. The City would benefit from taking time to analyze and study the impact of the new law on the City's Moratorium and any necessary revisions of the Moratorium.

- G. Pursuant to Minn. Stat. § 462.355, subd. 4, the City is authorized to enact by ordinance a moratorium to regulate, restrict or prohibit land uses within its jurisdiction to protect the public health, safety, and welfare. Specifically, the City is authorized to enact a moratorium ordinance to allow it to undertake a study to determine whether to adopt any regulations or restrictions, including siting and location of uses, related to the sales, testing, manufacturing, cultivating, growing, transporting, delivery and distribution of Cannabis Products.
- H. Pursuant to its general police powers and also Minn. Stat. § 421.221, subd. 32, the City may enact and enforce regulations or restrictions on Cannabis Products within the City to protect the public safety, health, and welfare, including restrictions and a moratorium on the sales, testing, manufacturing, cultivating, growing, transporting, delivery and distribution, during the pendency of a study to determine the need for police power regulations, including but not necessarily limited to any additional licensing and permitting that may be allowed, if any, by the State.
- I. Pursuant to the language of Chapter 342 cities, as soon as the bill becomes effective, may have authority to adopt an interim ordinance to prohibit a cannabis business from opening until January 1, 2025, to conduct studies or consider adopting or amending allowed restrictions on the operation of a cannabis business. Because the effective date of the Legislation is not until July 1, 2023, the City cannot take advantage of this authorization until on or after that date.

### **SECTION 2. FINDINGS.**

- A. The City Council finds there is a need to study (i) cannabis products, including products: using any part of the genus Cannabis plant; containing cannabis concentrate; infused with cannabinoids (including but not limited to tetrahydrocannabinol); extracted or derived from cannabis plants or cannabis flower; synthetically derived cannabinoids; and any lower potency hemp edibles that contain more than 0.3% of Tetrahydrocannabinol, (ii) cannabis businesses related thereto, and (iii) the impact of those businesses and products as related to allowed land uses and zoning, in order to assess the necessity for and efficacy of regulation and restrictions relating to the retail sales, wholesale sales, testing, growing, cultivating, manufacturing, transporting, delivery of or distribution of any of the products referenced herein, including through zoning ordinances or licensing, if allowed, in order to protect the public health, safety, and welfares of its residents.
- B. The study will allow the City Council to determine the appropriate changes, if any, that it should make to the Le Center City Code, including any necessary zoning changes.
- C. The time will allow for any state agency licensing cannabis businesses to rule make and adopt its model ordinances which will further aid the Council in studying and considering restrictions on the operation of a cannabis businesses and the use of the products listed in paragraph 1 above.
- D. The City Council, therefore, finds that there is a need to adopt a city-wide moratorium on the retail sale, wholesale sale, testing, growing, cultivating, manufacturing, transporting, delivery of, and distribution of Cannabis Products, including products: using any part of

the genus Cannabis plant; containing cannabis concentrate; infused with cannabinoids (including but not limited to tetrahydrocannabinol); extracted or derived from cannabis plants or cannabis flower; synthetically derived cannabinoids, or lower potency hemp edibles.

### **SECTION 3. MORATORIUM.**

- A. No individual, establishment, organization, or business may engage in the retail sale, wholesale sale, testing, growing, cultivating, manufacturing, transporting, delivery of or distribution of Cannabis Products, including products using any part of the plant of the genus Cannabis plant; containing cannabis concentrate; infused with cannabinoids (including but not limited to tetrahydrocannabinol); extracted or derived from cannabis plants or cannabis flower; synthetically derived cannabinoids, or lower potency hemp edibles, to the date allowed by Chapter 342; January 1, 2025. The City can, pursuant to Chapter 342, terminate this moratorium prior to January 1 2025 if it so chooses.
- B. Planning or zoning applications related to any of the products listed in Subsection A of Section 3 herein or applications from individuals, establishments, organizations, or businesses involved in the proposed sale, testing, growing, cultivating, manufacturing, transporting, delivery of or distribution of Cannabis Products within the City of Le Center shall not be accepted or considered from the effective date of this ordinance up to the time outlined in Subsection A of Section 3.
- D. This moratorium does not apply to the selling, testing, manufacturing, or distributing of Cannabis Products related to the Medical Cannabis Program as administered by the Minnesota Department of Health, provided that such activity is done in accordance with the regulations and laws of Minnesota regarding Medical Cannabis.
- E. Pursuant to Chapter 342, this moratorium does apply to the sale of THC Products allowed under the 2022 Legislation, which includes edible and nonedible cannabinoid products that contain no more than 0.3% of Tetrahydrocannabinol.

**SECTION 4. STUDY.** The City Council directs City staff to study the need for local regulation regarding the retail sale, wholesale sale, testing, growing, cultivating, manufacturing, transporting, delivery or distribution of Cannabis Products listed in Section 3(A) herein within the City of Le Center. Staff must also study the need for creating or amending zoning ordinances, licensing ordinances, as allowed by the state, or any other ordinances, as allowed and not preempted by the state, to protect the citizens of Le Center from any potential negative impacts. Upon completion of the study, the City Council, together with such commission as the City Council deems appropriate or, as may be required by law, will consider the advisability of adopting new ordinances or amending its current ordinances.

<u>SECTION 5</u>. **ENFORCEMENT.** The City may enforce this Ordinance by mandamus, injunctive relief, or other appropriate civil or criminal remedy in any court of competent jurisdiction. The City Council hereby authorizes the City Administrator, in consultation with the City Attorney, to initiate any legal action deemed necessary to secure compliance with this Ordinance. A violation of this Ordinance is also subject to a misdemeanor penalty which is incarceration of up to 90 days and a fine

of up to \$1,000 or both. Each day that a violation occurs constitutes a separate violation.

SECTION 6. TERM. Unless earlier rescinded by the City Council, the moratorium established under this Ordinance shall remain in effect until January 1, 2025.

SECTION 7. EFFECTIVE DATE. This ordinance shall be effective upon Summary Publication as allowed by law.

### COMMERCIAL BUILDING LEASE

THIS LEASE, made this 1st day of June 2022, by and between the City of Le Center, a municipal government entity, and Tri-Valley Opportunity Council, Inc. (Tri-Valley)

WHEREAS, Tri-Valley desires to lease from the City of Le Center that certain property located at 200 E. Bowler St., Le Center, MN, hereinafter referred to as the "Premises."

For and in consideration of the agreements and covenants contained in this agreement, the parties hereto mutually agree as follows:

- 1. **TERM:** The lease term agreement contemplated herein is a one (1) year lease agreement beginning on June 1, 2022. The parties have, however, agreed that beginning on June 1, 2023, Tri-Valley and the City of Le Center shall be entitled to review its financial portion and elect to continue with a month-to-month lease term or to exercise its option to pull out of the lease agreement, without penalty, with 30 days written notice.
- 2. **RENT:** Tri-Valley agrees to the following rental payment schedule:

\$600 per month @ City of Le Center pays utilities (gas & electric).

Rent shall be due on the first day of each month and shall be received by the City of Le Center via hand deliver or US Mail at 10 West Tyrone St., Le Center, MN 56057.

- 3. **USE OF PREMISES**: The leased Premises shall be used for the purpose of conducting all activities incident to a professional business. No part of the leased Premises shall be used for any purpose which is illegal, offensive, termed extra hazardous by insurance companies or which make void or voidable any insurance on the building or which may increase the premiums therefore, or which will interfere with the general safety of the surrounding neighborhood.
- 4. **ACCEPTANCE OF PREMISES:** Having taking possession of the leased Premises by Tri-Valley, shall be conclusive evidence the leased Premises were, on that date, in good, clean and tenantable condition and as represented by City of Le Center, providing that any defects shall be corrected by the City of Le Center during the duration of this lease.
- 5. **RIGHT TO ASSIGN OR SUBLET:** Tri-Valley shall not have the right to sublet any or all portion of the leased Premises, except with written consent of the City.
- 6. **SIGNS:** Tri-Valley shall have the right to erect any and all signs on theses Premises so long as said signs are in compliance with the local ordinances and any state and federal statutes or regulations. City of Le Center shall be responsible for all major maintenance and upkeep of the permanent outside signs except that Tri-Valley shall be responsible for all light bulbs and general maintenance of the signs.

- 7. **RULES AND REGULATIONS:** Tri-Valley shall use the leased Premises and the public areas in the building in accordance with such rules and regulations as may from time to time be made by City of Le Center for the general safety, comfort and convenience of the owners, occupants and tenants of the building, and shall cause Tri-Valley customers, employees, and invitees to abide by such rules and regulations.
- 8. **WASTE:** Tri-Valley shall use best efforts to conserve heat, air conditioning, water, electricity and shall use due care in the use of the leased Premises and the public areas in the building.
- 9. **RIGHT TO ENTER:** The City of Le Center, its agents and representatives may at any reasonable time after having advised Tri-Valley it intends to do so, enter and view and inspect the leased Premises. The City of Le Center, its agents and representatives may at any time in case of emergency, enter the leased Premises to do such act as the City of Le Center may deem proper in order to protect the leased Premises, the building or any occupants of the building.
- 10. **UTILITIES:** It is agreed that Tri-Valley shall pay for telephone, internet access, city water bill, and garbage removal associated with the Premises. Tri-Valley will be responsible for any hazardous waste removal generated by their business. Tenant shall have the duty to remove all snow and maintain the sidewalk and adjacent Premises in a neat and clean condition, and will be held liable should emergency vehicles not be able to gain proper access to the Premises. City of Le Center will plow the parking lot. City of Le Center will mow the lawn.
- 11. **EQUIPMENT:** Tri-Valley has use of all equipment within the Premises and is responsible for all associated maintenance and repairs of said equipment; and will return such equipment back to the City of Le Center in working order, but is not responsible for the normal wear and tear or the expended useful life of such equipment.
- 12. **REPAIRS, UPKEEP, MAINTENANCE, & ALTERATIONS:** During the term of this lease, Tri-Valley may make such alterations, additions or changes of a non-structural nature which are necessary and convenient for business needs. In addition, upon the City of Le Center's prior written consent, Tri-Valley may make any structural additions or changes they find necessary. Tri-Valley shall be responsible for all repairs, maintenance and the upkeep of non-structural portions of the leased Premises of the building, including the costs of all glass repaired not covered by insurance. The City of Le Center shall be responsible for all major repairs and maintenance to structural portions of the building, including the roof, walls, foundation, furnace, plumbing, water-softener, air-conditioner or other appliances.
- 13. **INSURANCE:** The City of Le Center agrees during the term of this lease they will carry public liability insurance on the Premises for property damage liability in the amount of not less than \$150,000 and general liability insurance to afford protections to a limit of at least \$500,000 in respect to injury or death of any one person and to a limit of at least \$1,000,000 in respect to any one accident or occurrence.

- 14. **MECHANIC'S LIEN AND USE OF PREMISES:** Tri-Valley shall keep the Premises free from all mechanic's liens, and if any mechanic's liens or liens of any kind shall be filed against the Premises, Tri-Valley shall within thirty (30) days thereafter, at its own cost and expense, cause such liens to be discharged or in the event it desires to contest said liens, it shall file a bond sufficient to indemnify the City of Le Center against all costs arising out of the mechanic's liens.
- 15. **FIXTURES:** Upon termination of this lease for any cause, Tri-Valley may remove any fixtures or equipment, regardless of whether such fixtures are attached, which have been installed on the Premises by Tri-Valley. However, any injury or damage to the building caused by the removal of such personal property, shall be repaired by Tri-Valley itself.
- 16. **CASUALTY:** In the event of total destruction of the leased Premises by fire, explosion, act of God or other casualty, this lease shall terminate upon the option of Tri-Valley. In the event of a partial destruction, the rent shall be abated in the proportion that the non-tenantable portion of the leased Premises bears to the entire leased Premises.
- 17. **CONDEMNATION:** In the event of condemnation by public authorities of the entire Premises or so much thereof that the balance is not useful for the purpose intended under the lease, then this lease shall cease and terminate as of the date of its taking.
- 18. **DEFAULT**: In the event a default shall be made by Tri-Valley in any payment provided herein, of in the case any mechanic's liens shall be placed against the leased Premises, then upon such event the City of Le Center shall send Tri-Valley written notice of such default, and if such default is not cured within thirty (30) days after such notice is sent, this lease shall be cancelled and terminated and the City of Le Center may without further notice or demand re-enter the leased Premises either with or without process of law and remove Tri-Valley from the Premises. Tri-Valley agrees that upon termination of this lease as herein provided, it will surrender and deliver the Premises peaceably to City of Le Center immediately upon such termination; including all entry keys to the building.
- 19. **ENTIRE AGREEMENT**: This agreement constitutes the entire agreement between the parties hereto and shall not be modified, amended, altered or changed except by written agreement signed by both parties to this agreement.
- 20. **NOTICES:** All notices to be given for any provisions of this lease shall be in writing and mailed to the other party at such address as the parties may provide in writing from time to time.

### **ORDINANCE NO. 2023-4**

### AN ORDINANCE PROHIBITING THE USE OF TETRAHYDROCANNABINOL (THC) PRODUCTS IN PUBLIC PLACES

WHEREAS, the City Council for the City of Le Center, Le Sueur County, Minnesota, is empowered under Minnesota Law to provide regulations for the general welfare and benefit of its residents; and

WHEREAS, the Minnesota Legislature recently enacted a law authorizing the recreational use of Tetrahydrocannabinol (THC) products and further, said law allows municipalities the authority to regulate and prohibit the public use of the same; and

WHEREAS, the City Council does hereby and herein ORDAIN as follows:

- 1. There shall be no public consumption of Cannabinoids, Cannabinoid products, products having a Cannabinoid Profile, products having a Cannabis Concentrate, Intoxicating Cannabinoids, Lower-Potency Hemp Derived Edibles, Synthetic Cannabinoids, or Tetrahydrocannabinol (THC) products, as those products are defined in Chapter 68, M.S.A. Section 342.01, as amended from time to time, in the City of Le Center at the following locations:
  - a. Any city owned or city leased property including the grounds, parking lot, or structures thereon:
  - b. City Hall;
  - c. City's Public Works Building;
  - d. Fire Hall;
  - e. Police Station;
  - f. Municipal Liquor Store;
  - g. Any Park;
  - h. Any Beach;

	i.	Any Playground;
	j.	Any Ballfield;
	k.	Any Concession Stand;
	1.	School grounds;
	m.	Fair grounds
	n.	Library grounds;
	о.	Any sidewalk;
	p.	Any parking lot;
	q.	Any cemetery;
	r.	Any festival or farmers market;
	s.	Any street or sidewalk;
	t.	Any other place where the public is invited to gather.
		y: A violation of this ordinance shall be a petty misdemeanor, punishable by $\epsilon$ \$290.
